TERMS AND CONDITIONS

- 1. These promotions are for new and existing Peruvian Brand Leaders
- 2. The new directly sponsored BL must be Peruvian and the points of new customers must be from Peruvian services.

- 4. For new Brand Leaders, new customers must be in the system in its First 30 days and activated on 60 days after that at the latest. For the bonus to count, the directly sponsored QBL must be qualified and active at the same time that new customer points are in the system.
- 5. For Existing Brand Leaders, new customers must be in the system between June 1st and June 30th, 2023 and activated on August 31st, 2023 at the latest. For the bonus to count, the directly sponsored QBL must be qualified and active at the same time that new customer points are in the system.
